

COVID-19 Family Agreement - September 2020

As we return to school, the safety and well-being of our children, their parents and carers and our staff are our highest priority. In order to keep everyone as safe as possible it is vital that we all take responsibility for following the rules, routines, systems and procedures. So that we all understand the responsibilities we have and the important role we all have to play in protecting our school community we have drawn up a family agreement.

Please take the time to read this through. Thank you for your co-operation and support in these times.

1. You must not come to school if anyone in your household are feeling unwell and are showing any of the following symptoms:
 - *a new continuous cough*
 - *a high temperature*
 - *a loss of, or change in, your taste or smell (anosmia)*
- You have Covid-19 symptoms and are currently awaiting for a test or test result.
- You or any member of your household has tested positive for Covid-19 within the last 14 days
- You have been contacted by 'NHS Track & Trace' and have been advised to self-isolate
- You have entered the UK from any country not exempt from the travel corridor list and are required to follow the current quarantine rules.

You MUST inform the school immediately if anyone in your household is symptomatic and the outcome of a COVID-19 test result.

2. You will contact school and give a clear reason for any absence your child has and if unwell, outline the symptoms that they are suffering.
3. If your child becomes unwell at school, you will collect your child from school immediately.
4. You will support all staff in their efforts to create an 'as safe as possible' environment during this crisis.
5. When dropping off and collecting your child, you will:
 - follow the 1 metre plus social distancing rules
 - adhere to the drop-off and collection times
 - use the designated entrance and exit route
 - ensure that only 1 adult accompanies them onto the site
 - ensure that your child remains next to you at all times on the playground
 - adhere to the 'drop and go' arrangements, leaving the site quickly and not loitering
6. You will not be allowed into the school building unless you have a pre-arranged appointment; this appointment will need to be made via the school office in advance and a face mask will need to be worn.
7. You need to inform the school immediately of any changes to parents/carers emergency contacts details.
8. Any medication must be brought into school via the school office and an administration of medication form completed. Please contact the school office directly regarding this.
9. Other than a packed lunch, water bottle, bag, hat and coat your child must not bring any other items into school from home.
10. You will ensure that your child arrives in their winter tracksuit/PE kit on PE days and earrings are removed or covered with tape.
11. Your child will need to use good respiratory and hand hygiene and you will also need to support your child at home with this.
12. You will continue to remind your child about social distancing rules but accept they are difficult to follow and that your child may not always do this successfully.
13. You will read all letters and messages that are sent home and respond to them when needed.
14. You understand that if your child behaves in a way that compromises another's health or safety e.g. coughing or spitting on purpose, then this will be dealt with in line with our revised Covid-19 behaviour policy.
15. You will not in any way verbally or otherwise act aggressively to anyone whilst on school grounds.
